• Annual ATL Chapter Technical Day 2023:

• Chapter Technical Day will be a rotating mini-course on year, with 3-4 technical day presentations the following year. Kyle Arsenault will be heading this as technical director with hopes to try and organise for spring or early winter to work around the ATC in the fall.

• Chapter plans to have 3 chapter meetings with round table discussions and technical presentations

• The ATL chapter has offered to host the ATC next, a committee will be formed within 6 months to a year to begin evaluating options for locations and logistics.

• NFLD Chapter:

 \circ Going forward new A/V gear will be set up for meetings so that it will be easier to join remotely. Jeff Tuma offered to provide some CMVA contacts from NFLD to Matt Firth for discussions on boosting membership in NFLD.

• Increase Membership:

• Chapter is attempting to Promote the CMVA through LinkedIn, Facebook, <u>www.cmva.com</u>, Vibs magazine, word of mouth, as well as presenting to Post Secondary Institutions.

• Word needs to get out that we are ISO accredited for CAT I,II,III, as well as the sole provider of alignment certifications worldwide.

• Post Secondary Presentations:

Update from the National:

• The first alignment certification was completed at the ATC Niagra, with another TBD in the spring in Ontario and the fall in Victoria. Currently working on expanding the trainers to offer more opportunities.

• Category 4 Exam- Committee is hoping for the end of 2024 to have exam and body of knowledge completed. Currently having discussions on other ISO vibration accreditations acceptance as prerequisites.

• A committee has been formed for Ultrasonic certifications and has had its first meeting towards ISO ultrasound certification, starting with level 1&2.

• National ATC Victoria – Venue has been decided, and currently working on the logistics of transport between the hotel and venue.

• Website training/certification course calendar is live on the website <u>www.cmva.com</u>. The website profile has info on current membership status and certification expiry. The website store now contains some textbooks of case studies and should be expanding in the future.
